September 19-20, 2022

About the Conference

The Annual Conference reflects a commitment to ending domestic and sexual violence in Tennessee through education, prevention, policy development, and victim services. This conference is designed for victim service providers, law enforcement, court personnel, batterers' intervention programs, social workers, health care providers, students, and university faculty.

Workshop Presentations

The Coalition is seeking proposals for conference workshops. The 2022 Annual Conference theme is **Radical Reimagining: Innovative Practices for Safer Communities**. All workshop proposals should be victim-centered, trauma-informed, social justice focused and include culturally competent approaches. Preferred training topics include the anti-violence movement, dismantling systems of oppression, working with rural populations, legal advocacy, and leadership development. Proposals that incorporate innovative practices and promising emerging trends are especially welcomed this year. Other topics may include:

- Serving Vulnerable Populations
- Batterer's Intervention Programs
- Strategies for Engaging Men as Allies
- Strangulation
- Human Trafficking
- Law Enforcement Response / Collaboration with Law Enforcement
- Intersection of Purity Culture and Sexual Assault
- The Intersection of SA, DV, and Other Health Issues
- Tech Safety
- Identifying and Addressing Gaps in Services
- Coordinated Community Response Teams
- Working with Survivors with Mental Health or Substance Abuse Issues

1. Proposed workshops should fit into a 75 minute time slot, including time for introductions. Creative formats that encourage audience participation and discussion are encouraged.
2. Speakers are responsible for providing handouts, should they choose to use them.
