## INTRODUCTION

---

High-quality professional development opportunities are essential for employees to be successful in any position. The Tennessee Coalition to End Domestic & Sexual Violence (TN Coalition) strives to provide high-quality training opportunities which support its member programs and allied agency staff as efficiently and effectively as possible. It is our top priority to give our member DV/SA organizations across the state the tools and resources they need to deliver inclusive, holistic, and trauma-informed services to survivors.

This Training Catalog is designed to outline all training offerings available for TN Coalition member programs, allied agencies, and the general public. The various sections of this catalog provide in depth details about ongoing training opportunities as well as a list of topics that may be specially requested by members.

The state of Tennessee does not mandate trainings for advocates at domestic or sexual violence organizations; Additionally, individual organizations each determine their own required training programs for employees; however, the TN Coalition strongly recommends all advocates take advantage of the foundational-level trainings we offer which include, but are not limited to, the ABC's of Advocacy e-learning course and the Senator Tommy Burks Victim Assistance Academy (in-person or virtual). ## TRAINING CERTIFICATIONS

---

Certificates of completion are issued for all Tennessee Coalition trainings. Some trainings are eligible for professional certifications or continuing education units, such as those listed below.

- **TN-NASW Social Worker CEUs**
  - The TN Coalition seeks National Association of Social Workers, Tennessee Chapter (TN-NASW) approval on several of our trainings each year, including the Senator Tommy Burks Victim Assistance Academy and the Annual Conference. Social workers seeking CEUs may email [training@tncoalition.org](mailto:training@tncoalition.org) with questions regarding approval status or hours available for individual trainings.
- **TN P.O.S.T. Units**
  - The Tennessee Peace Officers Standards and Training (P.O.S.T.) Commission is responsible for developing and enforcing standards and training for all local police officers. TN Coalition P.O.S.T. approved trainings are open to other professionals as well, but police officers who attend may count said trainings towards their P.O.S.T. required 40 hours of in-service training annually. - **NACP Provisional Level Advocate Certification**
  - The National Advocate Credentialing Program (NACP) recognizes the TN Coalition Senator Tommy Burks Victim Assistance Academy (see pages 6 and 8) as an approved 40-hour training program for Provisional Level Advocate certification. No field experience is required; NACP requires an application with application fee to be submitted with proof of completing the 40-hour program. ### **ABC's of Advocacy**

ABC's of Advocacy is an eight-part course which focuses on the foundational concepts of domestic and sexual violence advocacy. Lessons include:

- The History of Domestic Violence & Sexual Assault
- Dynamics of Domestic Violence
- The Role of the Advocate
- Safety Planning
- Crisis Counseling
- Working with Underserved Populations
- Coordinated Community Response
- Legal Advocacy

The ABC's of Advocacy course is recommended for all new advocates and also serves as a great refresher for anyone already working in the field. It is open to member programs of the TN Coalition only.

### **Senator Tommy Burks Victim Assistance Academy (Virtual)**

The Senator Tommy Burks Victim Assistance Academy is a comprehensive basic level training designed for victim service providers. It is open to members and non-members. The goal of the Academy is to improve services to crime victims by enhancing the knowledge and skills of victim advocates (best-suited for those with 5 years or less of experience). This on-demand 40 hour virtual Tennessee-specific training is modeled after the National Victim Assistance Academy with topics including History of the Movement, Cultural Humility, Crisis Intervention, Building Collaboration, and much more. ### **Bystander Intervention**

The Bystander Intervention training explores pivotal concepts and definitions around bystander intervention. It takes viewers into scenarios to practice safe intervention and discuss the motivation behind sexual violence. This training covers consent, the bystander effect, and the prevalence of sexual violence on college campuses. Learn what keeps people from intervening, how to combat sexual violence, and how to intervene effectively.

### **Learning Financial Fundamentals**

This 3-part course is for anyone who wants to know more about money, including the basics of budgeting and savings, to understanding credit, to more complex information about investments and building for your future. We hope that there is something for everyone in this course to help empower you to start where you are and build towards where you want to be.

## IN-PERSON TRAINING EVENTS

---

### **Senator Tommy Burks Victim Assistance Academy (In-person)**

*NACP Pre-approved for Provisional Level Advocate Certification; P.O.S.T. Certified as needed*

The in-person Senator Tommy Burks Victim Assistance Academy (Academy) is the only 40-hour basic level victim advocacy training in Tennessee. Once a year, the Academy brings professionals together from a multitude of Tennessee agencies to learn about the various forms of victimization, build collaboration, and strengthen the field of victim advocacy. Based on the National Victim Assistance Academy Training, the Academy provides comprehensive, standardized and Tennessee-specific training for professionals from across Tennessee who work in domestic violence shelters, rape crisis centers, courts, law enforcement agencies, probation offices, emergency response teams, child advocacy centers, and other victim advocacy agencies. The Academy gives professionals new to the field (ideally 5 years or less of experience) the opportunity to learn from experts in victim services as well as from each other. The 2024 in-person Victim Assistance Academy will take place at the University of Tennessee at Chattanooga, June 2nd-7th (Sunday evening - Friday afternoon). The application to be considered for attendance as well as additional details can be found at [tncoalition.org](https://tncoalition.org). Applications are accepted December-March every year leading up to the Academy.

### **Batterer Intervention Programs Annual Conference**

The 2024 BIPs Annual Conference is set to take place June 6<sup>th</sup>-7<sup>th</sup> in Nashville, TN. Registration will open in April. ## TRAINING TOPICS AVAILABLE BY REQUEST

---

TN Coalition trainers provide educational programming on a variety of topics including but not limited to the alphabetized list below. In an effort to best serve our collective, we offer these specialized trainings to TN Coalition member programs only\*. The TN Coalition makes every effort to meet unique training requests by member programs but may refer some requests elsewhere based on evolving capacity. We are happy to tailor trainings according to experience level and other specific group needs. ### **Alcohol and Drugs: Intersecting with Interpersonal Violence and Sexual Assault**

This training discusses the propensity for survivors to use drugs and alcohol as a coping method while experiencing intimate partner violence and sexual assault. It explores the ways abusers weaponize a survivor's drug use, as well as the barriers to service that a survivor may face.

### **Alcohol and Drug Facilitated Sexual Assault**

Attendees of this training will be able to identify the weapons and tactics of perpetrators of alcohol and drug-facilitated sexual assault, as well as the concerns and issues that may arise for a survivor of this particular crime. Attendees will put their new knowledge into practice with an activity on crafting supportive responses. This training is suitable for all first responders, but is especially tailored for law enforcement officers and victim advocates.

### **Intersection of Alcohol, Drug Use, and Mental Illness**

This training is a deep-dive into the cycle of alcohol, drug-use, and mental illness for a survivor of domestic or sexual violence. It explores the precipitating mental health issues or exacerbating preexisting mental health illnesses that may arise for a survivor.

### **Collaboration**

This training covers the importance of, search for, and difficulties with collaborating with the necessary community allied professionals in order to provide and facilitate holistic comprehensive services to survivors.

### **Crisis Intervention and De-Escalation**

This training covers the initial steps that are most often taken when first disclosures are made, often when the survivor is still in the initial stages of trauma response. It offers de-escalation practices for engaging with persons who are expressing agitation or anger specifically in shelter settings.

### **Domestic Violence 101**

Attendees will understand the basic dynamics of domestic violence, the cycle of violence, the power and control, and equality wheels. Answering questions such as “why don’t they just leave” and the need for full community collaboration to increase safety for survivors and holding perpetrators accountable (and what that can look like).

### **Elder Sexual Abuse**

Attendees will gain information on issues specific to elders when a sexual assault is suspected or has been disclosed. Includes special considerations for serving vulnerable adults.

### **Emergency Preparedness**

This training is designed to give domestic & sexual violence agencies the knowledge and tools needed for emergency preparedness. Attendees will gain information and resources on designing preparedness plans implementing policies for natural disasters.

### **Equity**

Inequity is rooted at the core of most societal issues and barriers to health and justice, and building practices of equity is the cornerstone of how we begin to nurture safer communities. This training discusses social determinants of health and the effects of violence on our communities. The training also reviews the origins and progress of violence prevention work and facilitates conversation around moving this work forward with tangible and actionable steps.

### **Grant Writing and Grant Management**

Grant writing and grant management are essential practices for most domestic and sexual violence programs. This training provides helpful tips for crafting grant proposals that will stand out and set your program up for success. You will also gain practical instruction on managing grants, including timeline management, grant compliance, data collection, and effective reporting.

### **Intersection of Domestic & Sexual Violence**

Attendees will receive a comprehensive understanding of the intersections of domestic and sexual violence. Topics covered will include root causes, shared risk and protective factors, shared targeted programming, and prevention strategies.

### **Personnel Issues/Organizational Management & Leadership Development**

Effective leadership is a core component for nonprofits to achieve their mission, and a mission cannot be sustained without developing new empowered leaders. This training addresses the key tenants of organizational management and leadership development through the lens of a domestic or sexual violence agency.

### **Role of the Advocate**

This training is designed for advocates with three or fewer years of working directly with survivors. It covers a variety of subjects such as the advocate's basic role and responsibilities, trauma informed care, best practices for crisis calls, and more. Attendees are also given a number of scenarios to put their new knowledge into practice.

### **Your SART 101**

This training offers the framework for establishing a Sexual Assault Response Team (SART), what true community-based systems change looks like, and how - with that collaboration - you can build and sustain an effective SART.

### **Serving Refugee and Immigrant Survivors**

This training explores special considerations for effectively serving refugee and immigrant survivors. Build your skills for working across cultures with agility and gain resources for developing partnerships with refugee and immigrant populations in your communities.

### **Sexual Violence 101**

This training is an introduction to the root causes of sexual violence, the historical aspects of sexual violence, and social norms that create environments that are indifferent to sexual violence. During this workshop, participants will explore the impact of sexual assault on survivors, including their physical and emotional reactions. Participants will also examine the damaging myths surrounding sexual violence.

## **Stalking**

This session examines the crime of stalking within domestic/sexual violence. It includes information on stalking behavior, the impact on victims, evaluating level of danger, safety planning and additional important context for advocates working with stalking victims.

### **Stalking Law Enforcement Edition**

This training examines the crime of stalking within domestic/sexual violence. It focuses on information most pertinent to law enforcement officers, including identifying stalking behavior, level of danger, and best practices in response.

## **Trauma and Trauma-informed Care**

Participants will learn the basics of trauma, trauma effects on the brain, and how a trauma-informed approach deeply impacts a survivor's experience.

### **Trauma and Secondary Trauma**

Understanding Trauma, survivor trauma response and dynamics of secondary trauma and how lack of dealing with secondary trauma can adversely affect first responders, advocates, and survivors.

### **Trauma-informed Supervision**

As victim-service providers, one of our top priorities is to understand and implement trauma-informed practices with the victims/survivors we serve. Just as important as our interactions with clients, is our interactions with our staff. Trauma-informed supervision practices boost employee morale, mitigate turnover, and improve employees' performance. This training explores how to prioritize and implement trauma-informed supervision in your DV/SA organization.

## **The Impact of Trauma on Children**

This training explains trauma's harmful impact on children's neurodevelopment and functioning. With a foundational understanding of trauma impact, attendees then explore the trauma-informed practices that nurture healthy brain development, healthy relationships, and effective coping skills for children and young adults who have experience trauma.

### **Trauma-informed Activities for Children in Shelter**

This training offers a comprehensive understanding of the importance of building resilience and connection in children residing in domestic violence shelters. You will acquire practical tools and resources to effectively engage children and support their healing journey while fostering a nurturing relationship with their survivor parent.

### **TN Standards of Service and Their Implementation**

Attendees will gain a foundational-level understanding of TN standards of service for victim service providers. Research-based guidelines are offered to promote consistency across services, high ethical standards, and the highest quality programming for survivors of violence in Tennessee.

### **Violence Prevention**

This training fully defines prevention work, including all levels of intervention from individual to societal, and discusses the importance of moving upstream to work towards the overall goal of ending violence across the state. Additionally, the intersectionality of violence is explored to highlight the importance of anti-racism work and other social justice initiatives in fully addressing violence prevention. Examples of current violence prevention initiatives are given, including specific success stories and ideas for how to incorporate prevention programming into existing organizational efforts.
